I. SCOPE OF SERVICES: This letter will confirm your request that Farlow & Associates will represent you with respect to drafting a pre-nuptial agreement documents for the your contemplated marriage to, \_\_\_\_\_ (insert fiancé's first, middle, and last name).

II. FEE: With all new matters, we require advance payment via credit card for services to be rendered. The advance payment for dissolution or uncontested divorce documents is \$350.00. III. WHAT THE FEE COVERS: The advance payment covers only the following: a) our review of the data you provide in response to our list of questions, b) preparation by our attorneys of the initial draft of your documents, c) our review of any comments or corrections for the initial draft, d) final revision of the documents, and e) transmission of those documents to you via e-mail, or by snail mail if you prefer.

IV. WHAT THE FEE DOES NOT COVER: The advance payment does not cover a) any negotiation between you and your future fiancé or that person's legal representative, or b) any representation of your interests in any future action to enforce or challenge the Pre-Nuptial Agreement.

V. OUR COMMITMENT TO YOU: We will prepare documents consistent with the information that you provide to us, and provide you with either a hard copy or an electronic copy for your records.

VI. WHAT YOU MUST DO: a) You agree to provide to us a photocopy of your Ohio Driver's License, or your Ohio State Identification card if you do not have a driver's license. b) You agree to review and answer the list of questions that we have prepared, as well as any follow-up questions that we may need to ask you. c) You agree to work directly with your fiancé to finalize the paperwork, and retain your originals in a secure location.
